## So Cal Mirage 1<sup>st</sup> Annual December to Remember Winter Jam!!! Tournament Rules

1. Teams must check in 30 minutes prior to first game in pool play. Teams that fail to check in will have all pool play games declared a forfeit.
2. Teams must have a minimum of eight (8) players in the dugout at game time or a forfeit shall be declared.
3. Home team for all games shall be determined by a coin toss prior to each game. Home team shall keep official score. If home team does not have an official scorekeeper, the opposing team shall become the home team.
4. All pool games shall be seven (7) innings or one-hour fifteen minutes No New Innings whichever comes first. Bracket plays one-hour fifteen minutes (no new inning). If any bracket game is tied at the end of seven innings or when time limit has been reached, the international tiebreaker shall be used. **All Pool/Bracket Games 1:15 No New Inning.**
5. If there is a tie in non-bracket pool play, the ties shall be broken as follows;
  - A – Head-to-Head Competition
  - B – Runs allowed
  - C – Runs scored
  - D – Coin Toss
6. Any team leading by 10 runs after four innings or 8 runs after five innings shall be declared the winner
7. AFA rules shall be used unless accepted herein
8. Protests – a \$150.00 (cash) fee is required for any rule interpretation protest. The fee will be refunded if the protest is found to be valid. The game officials and the Tournament Director will handle protests immediately on site.
9. Eligibility - Eligible players must;
  - A - Be listed on the official roster
  - B - Meet AFA age classification requirementsIf there is an eligibility protest, the team manager must show proof of all the above requirements including proof of age of the player in question or the player may be declared ineligible. The team will forfeit the game under protest and the player may not participate in any further games until proof of protest is clarified
10. The Tournament Director will have the right to shorten, move or reschedule games as the need may arise, in case of rain there will be no refunds
11. If you have a fifth game in pool play, it will not count as a win or loss and will not affect your standings.
12. **You may bat your entire line up in pool play if you choose, Free Substitution. In Championship play you may bat 2 extra players. They will be called the EP. AFA RULES**
